#### **Fire / Ambulance Department:**

There were 43 EMS calls and 7 fire calls during May.

Dan Barletta will be installing gutters at the firehall to address the rainwater drainage issue.

Tentative date for fire department open house / recruitment drive will be July 12<sup>th</sup>.

A discussion regarding the practice of Henry Hiteman filling pools as a fundraiser was discussed.

# **COMMITTEE REPORTS:**

**Bisby Hall:** Dan Barletta continues to work on the entrance way to Bisby Hall.

Clean Energy: The reimbursement for the cost of the firehall insulation has been received from NYSERDA.

**Grants:** The search for possible grants is continuing.

<u>Community Activity Committee:</u> Tori Roberts continues to work on the Slide into Summer event; Chobani Yogurt will be donating yogurt to the event. Mayor Sandy reported that the cost of providing music in the park has been funded by public donations.

<u>Comprehensive Plan:</u> The committee continues to work toward developing a plan.

**Zoning / Codes:** Committee on hold.

### **OLD BUSINESS:**

- Local Law #2 of 2025 Village of West Winfield Residential Municipal Solid Waste Fee Act has been passed by the Village Board.
- The part-time office clerk position has been filled.
- Due to the estimated cost, no further action will be taken on the proposed installation of a pickleball court.
- EMR has been engaged to explore the possibility of creating an ambulance district.
- The Board discussed the installation of the digital sign purchased by Henry Hiteman. The consensus of the Board is that a resolution is needed.

Motion for the Clerk Treasurer to prepare a resolution was made by Trustee Niederlander and seconded by Trustee Murphy. Ayes: Smith, Murphy, Niederlander, Allen and Wheat. Nays: None A draft of the resolution will be prepared for the July Village Board meeting.

#### **NEW BUSINESS:**

- Trustee Murphy noted an increase in the number of Village residents raising chickens. The Village Clerk's office will research the issue and provide feedback at the July meeting.
- On or about July 27<sup>th</sup> the NYS DOT will begin a roadwork construction project downtown at the four corners (Main St / North and South Streets).
- A ZOOM workshop regarding the proposed ambulance district will take place at 4:00 pm on June 17<sup>th</sup>.
- Ambulance donations will be segregated in the general fund money market fund instead of opening a separate banking account which was authorized at the May 2025 Village Board meeting.
- Fire Department pool filling policy and rates was discussed see above.
- Gutter installation is needed for the firehall see above.

**PUBLIC COMMENT:** There was no public comment.
