<u>Codes:</u> Two building permits were issued. Rental inspections have been completed at the Scott House and Talbot House apartments.

Fire / Ambulance Department:

The insulation project at the firehall has been completed. Trustee Murphy suggested that curb stops be installed along the back of the building so that people who are parking in back of the firehall don't back into the new insulated walls.

There were 35 EMS calls and 6 fire calls during April. The emergency generator at the fire hall needs to have a part replaced. The new fire truck was delivered on Sunday, April 13th. The new truck, Engine 129, needs a "pump radio" installed. Chief Moxham provided a price quote from JPJ Electronic for \$2,443.84.

<u>**Clean Energy:**</u> The firehall insulation project is complete. A copy of the paid invoice needs to be submitted the NYSERDA in order for the Village to receive the balance of the NYSERDA Grant.

<u>Grants:</u> The search for possible grants is continuing.

<u>Community Activity Committee:</u> Tori Roberts continues to work on the Slide into Summer event; Mayor Sandy has requested that the new firetruck and possibly the ambulance be available at the event.

<u>Comprehensive Plan:</u> A second mailing of surveys may be mailed out.

Zoning / Codes: Committee on hold.
