INTENT:

It is the intent of this bid proposal to solicit bids for material, equipment and labor to mill and resurface with asphalt various streets within the village of West Winfield, the successful bidder will furnish all materials, labor and equipment to deliver, place and compact the asphalt as per specifications.

SPECIFICATIONS

1. STREETS TO BE PAVED

Church Street and Curtis Avenue located within the Village of West Winfield, NY

2. SCOPE OF WORK

- A. Cold mill the existing asphalt surface to a depth of +/- 2". The Village of West Winfield will provide all trucking of the milled material. Successful bidder shall provide the milling machine and labor for all cleanup work required.
- B. A diluted tack coat will be applied to the milled surface per NYS DOT application rates for milled pavement.
- C. A 19MM binder will be supplied and installed at the swale on the down slope of Curtis Avenue by the successful bidder.
- D. 2" of 12.5MM HMA top course shall be supplied and installed over the entire surface by the successful bidder.

3. TIME FOR COMPLETION:

PAVING MUST BE COMPLETED BY Friday, October 23, 2026

4. PREVAILING WAGE RATE SCHEDULE:

The successful bidder must comply with the current wage rate schedule and all other requirements by the New York State Department of Labor certified payroll affidavits are to be submitted to the village of West Winfield Clerk's Office. It is expected that work performed under this proposal shall be accomplished during the hours of 6:00 am and 5:00 pm Monday through Friday, exceptions to this must be approved by the Village of West Winfield Board of Trustees.

5. BIDDING PROCEDURE:

All bidders are required to sign the attached non - conclusion bidding certificate.
